In addition, there are a number of technical and standing *committees* for which *chair* and *co-chair* positions will be available. The term of office for each position is from October 1, 2014 to September 30, 2015. Installation of Officers will be conducted during the September 2014 meeting which will be held at the first annual Texas Civil Engineer's Conference (CECON) in Galveston.

Candidates for officer positions must be members of the Society and a dues paying member of the Texas Section (subscribing member), in any grade of membership of the Society unless otherwise noted. The Officers constitute the Board of Direction of ASCE Houston Branch in which the government of ASCE Houston Branch shall be vested, and shall be the Trustees provided for by the By-Laws under which ASCE Houston Branch is organized. Members of the Board of Direction shall be known as the elective officers of ASCE Houston Branch and shall be elected by vote from the subscribing membership of ASCE Houston Branch. The duties of each Officer position are provided in the Constitution, By-Laws, and Rules of Operation of ASCE Houston Branch.
